## WESTERN AUSTRALIAN REGISTRAR AND COMMISSIONER OF TITLES JOINT PRACTICE: VERIFICATION OF IDENTITY

The Western Australian Registrar and Commissioner of Titles Joint Practice: Verification of Identity (referred to here as the VOI Practice) commenced on 1 July 2012 with a six month transitional implementation period. During the transitional period, industry may implement the VOI Practice as and when they are ready to do so with full compliance expected on specified documents lodged on and from 2 January 2013.

Landgate has scheduled a series of **REGIONAL** industry training workshops about the VOI Practice. These workshops have been designed to assist property industry professionals gain an understanding of the new VOI Practice and its practical implementation.
