

NOTICE TO SURVEYORS T3/2010

Items 1 to 2 in this notice are to be considered as special directions concerning plans and surveys pursuant to Regulation 5 of the *Licensed Surveyors (Transfer of Land Act 1893) Regulations 1961.*

MISCELLANEOUS PLAN AND SURVEY ISSUES

1. e-lodgement of Strata/Survey-Strata Plan Forms

In T4/2009 (23 November 2009), item 2, Surveyors were advised Landgate would accept a "scanned" signed copy of the Form 7 and Form 26 lodged as a PDF file, and the original signed archival hardcopy was to be retained by the surveyor.

Surveyors are further advised that the original archival hardcopy can be produced on any print quality paper, and that "goatskin parchment" is not required.

It is the Surveyor's responsibility to ensure that the legibility of the scanned signed copy of Forms 7 and 26 is sufficient to meet Landgate's scanning requirements, otherwise the forms will be rejected.

This direction becomes part of Sections 4.8.1 and 5.7 of the Strata Titles Practice Manual.

2. The "Approved By Western Australian Planning Commission" Panels on Multi-sheet Deposited Plans

After a successful pilot, the Electronic Transfer of Deposited Plans (etDP) process between Landgate and the Western Australian Planning Commission (WAPC) was implemented on 26 July 2010.

As a consequence, WAPC now only endorses the first sheet of a Deposited Plan.

Landgate requests that the "Approved by Western Australian Planning Commission" panels for sheet 2 onwards of a multi-sheet Deposited Plan be struck out or removed from the DP template.

Amendments to examples and text in the Survey and Plan Practice Manual will be available at the January 2011 update.

3. Standard Format to be Adopted for Emails and Attachments Relating to Plan Lodgement

With the implementation of etDP process, Landgate now captures all emails for ePlans into the Electronic Document Record Management System (EDRMS).

To assist Landgate to integrate emails received, it is requested that the following standard format be adopted for emails sent to <u>plan.reg@landgate.wa.gov.au</u> for the lodgement of Deposited and Strata Plans.

Surveyors are requested to adopt the following:

- Only **one** Deposited Plan or Strata Plan is sent in each email to allow the contents of the emails to be managed and stored more efficiently;
- Information relating to a particular Plan, including the pdf of the Plan and the Surveyor's Report, are to be attached as individual documents – no zip file formats;
- A standard format to be used in the subject line/headings of the emails (see below); and
- Uniform naming of the documents / information relating to a Plan. (see below) Landgate strongly encourages all plan related documents, such as release letters, to be sent via emails.
