# 1. DESCRIPTION OF AGREEMENT LAND

Plantation Interest Number to be stated. If share, specify. If the Registered Proprietor of the Affected Land is not the proprietor of an interest in fee simple in the title, but has for example a leasehold interest then the following should be included in this panel (ie. as to Lease H..... over Lot... on Plan ....) or refer to Deposited Plans depicting affected area of land contained in the title.

Lot and Diagram/Plan/Strata/Survey-Strata Plan number or Location name and number to be stated.

Extent - Whole, part or balance of the land comprised in the Certificate of Title to be stated. If part, refer to Deposited Plan depicting affected area of land contained in the title.

#### 2. ENCUMBRANCES

Only encumbrances against the Plantation Interest are to be shown.

The documents shown are to be identified by nature and number. The plan/diagram encumbrances shown are to be identified by nature and plan/diagram number. Strata/survey-strata plan encumbrances are to be described as "Interests on strata/surveystrata plan".

#### 3. TRANSFEROR

State the full name of the Transferor/Transferors (Registered Proprietor of the Tree Plantation Interest).

#### 4. CONSIDERATION

To be expressed in words or in figures.

#### 5. TRANSFEREE

State the full name of the Transferee/Transferees and the address/addresses to which future notices can be sent. If a minor, state date of birth. If two or more state tenancy eg; Joint Tenants, Tenants in Common. If Tenants in Common specify shares.
