## PROPOSED NEW SCALE OF FEES AS OF MONDAY 6 SEPTEMBER 2004

Subject to the Governor's approval in Executive Council, DLI advises that a new scale of fees will apply from the commencement of business on Monday 6 September 2004. The new scale of fees relates to document registration and survey lodgement.

The proposed fee amendments will increase the base land transaction document registration fee for freehold and Crown land from \$77.00 to \$79.00.

Other fee amendments include the following:

- An application to register a strata/survey strata plan increases to \$79, plus an additional
  lot fee of \$6.00. The new lot fee of \$6.00 applies for each lot shown on the strata/survey
  strata plan, other than a lot that is proposed to be vested in the Crown under the Town
  Planning and Development Act 1920 section 20(1), or a proposed common property lot
  on a survey-strata plan.
- The fee for rejecting a document under Section 192(1) of the Transfer of Land Act has been increased to 75% of the registration, recording or lodgement fee, rounded down to the nearest multiple of \$1.00. For example, 75% of the basic document registration fee of \$79.00 is \$59.25, would round down to \$59.00. Similarly, for a transfer where a registration fee of \$409 has been paid, the 75% rejection fee would be \$306.75 and rounds down to \$306.00.
- The production fee for duplicate titles is increased by \$1.00 to \$39.50 for the first Certificate of Title. The fee for producing subsequent duplicate Certificates of Title, for the same document, remains at \$6.00 for each additional duplicate Certificate of Title.
- The fee for the withdrawal of a document from registration increases by \$1.00 to \$39.50.
- An application to send a 21 days notice (Section 138B TLA) increases by \$4.00 to \$158.00
- A new fee for a digital title historical search listing of \$6.00 has been introduced.
- The deposited plan general fee (if deposition with the Western Australian Planning Commission (WAPC) is not required) increases by \$3.00 to \$130.00, plus the fee for each lot, other than a lot vesting in the Crown under section 20A of the Town Planning and Development Act 1928, increases by \$1.00 to \$51.00.



- The strata/survey strata plan general fee (if deposition with WAPC is not required) increases by \$2.00 to \$112.00, plus the fee for each lot shown on the plan, other than a lot that is proposed to be vested in the Crown under the Town Planning and Development Act 1928 section 20A(1) or in the case of a survey-strata plan, a proposed common property lot, increases by \$1.00 to \$36.00.
- The fee for preparing WAPC copies of surveys remains at \$53.00 and the copy service is expanded to include strata plans (if required).
